1. Information on how to enter and the prize forms part of these Terms and Conditions. Entry into this promotion constitutes acceptance of these Terms and Conditions.

 - 2.1 have an account number with TNT and:
 - 2.2 are expressly invited by TNT to enter this promotion.
 - (a) receive the TNT direct mail piece;
 - 2.3 ('Eligible Entrants').
