

TNT Express Priority Campaign Terms and Conditions

1. Information on how to enter and the prize forms part of these Terms and Conditions of entry. Entry into this Priority Campaign ('Promotion') constitutes acceptance of these Terms and Conditions.
2. The promoter is TNT Express Worldwide (NZ) Limited (registration number 76016) of Joseph Hammond Place, Airport Commercial Park, Auckland International Airport, New Zealand ('**TNT Express**').
3. Subject to this Paragraph and any conditions described in Paragraph 4 below in respect of the Promotion, entry is open to a person who:
 - (a) (If a natural person) is a New Zealand resident and over the age of eighteen (18) years or (if a company) is a registered New Zealand company; and
 - (b) Strictly complies with these Terms and Conditions; and
 - (c) Who has a current trading account with TNT Express which, at the date a claim is received by TNT Express for the Movie Pass, is not more than 60 (calendar) days in arrears.

('Eligible Entrant').

Individuals directly involved in the conduct of this Promotion who are employees of TNT Express, or agencies associated with this Promotion, and their immediate families, are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

4. To make a claim for an Event Cinemas double movie pass ('**Movie Pass**') the Eligible Entrant must:
 - (a) Send five (5) Priority shipments with TNT Express (export or import) between 1 December 2011 and 5pm on 31 March 2012 ('**Promotion Period**'); and
 - (b) Submit their TNT Express account number and the five (5) consignment note numbers of the priority shipments to nzmarketing@tnt.co.nz by 5pm on 31 March 2012.
5. An Eligible Entrant will only be permitted one (1) Movie Pass per claim for the consignment numbers submitted. Eligible Entrants may email multiple claims, provided such claims contain different consignment note numbers.
6. TNT Express may in its absolute discretion reject any claims. Claims will not be accepted or considered after 5pm on 31 March 2012.
7. You should allow 30 days for delivery of the Movie Pass.

8. Claims are strictly limited to the first one hundred and twenty five (125) Eligible Entrants who make a claim in accordance with these Terms and Conditions.
9. Claims used for this Promotion cannot be used in conjunction with any other offer or promotion. All claims submitted are the property of TNT Express.
10. A reference to a date and/or time in these Terms and Conditions will mean the date and/or time applicable in Auckland, New Zealand.
11. TNT Express takes no responsibility for lost, misdirected or incomplete claims. Any incomplete or incorrect claims will be void. Except for any liability that cannot be excluded by law, TNT Express (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under TNT Express's control); (b) any theft, unauthorised access or third party interference; (c) incorrect details lodged by entrants; (d) any prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by TNT Express) due to any reason beyond the reasonable control of TNT Express; (e) any variation in prize value to that stated in these Terms and Conditions; (f) any tax liability incurred by a winner or entrant; or (g) use of the Movie Pass (h) for any other reasons beyond the reasonable control of TNT Express.
12. The Movie Pass is not transferable, negotiable or exchangeable for cash or otherwise. The judge's decision will be final and no correspondence will be entered into. The Movie Pass will only be awarded following winner validation and verification, including but not limited to TNT Express verifying that the Eligible Entrant booked five (5) Priority shipments with TNT Express during the relevant Promotion Period.

If the Eligible Entrant nominates an employee or officer of the Eligible Entrant to receive the Movie Pass (**Nominee**) then the Eligible Entrant warrants it has obtained the consent of the Nominee for the purpose of TNT Express using the personal information of such Nominee in the same manner as that of the Eligible Entrant as set out in these Terms and Conditions (including but not limited to this Paragraph 13) and indemnifies TNT Express against all liability, loss and damages suffered by TNT Express resulting from a breach of such warranty.
14. Participants warrant that the information they provide in entering this Promotion is true and accurate and is not confidential.

TNT Express reserves the right to vary any prize or may substitute a prize for a prize of like or equal value or cancel this Promotion if it is no longer able to run the Promotion due to reasons beyond its control, subject to approval by any applicable authorities (if required). TNT Express will not be liable for any losses to any party arising from any variation or cancellation.
