

## TERMS AND CONDITIONS TNT MOVIE TICKET PROMOTION

- (1) The promoter is TNT Australia Pty Limited ABN 41 000 495 269 trading as TNT Express ("TNT") of 201 Coward Street, Mascot NSW 2020, Australia.
- (2) This TNT Movie Ticket Promotion ("**Promotion**") is only open to recipients who directly receive this Promotion along with the Application Form from TNT. TNT may in its absolute discretion reject any Application Form. Late Application Forms will not be considered.
- (3) Information on how to enter this Promotion and to claim two (2) Movie Vouchers ("**Voucher**"), offered in this Promotion, form part of these Terms and Conditions. Entry into this Promotion constitutes acceptance of these Terms and Conditions.
- (4) An Application Form must be submitted in strict accordance with these Terms and Conditions.
- (5) This Promotion is not open to employees of the TNT group of companies or any other person involved in this Promotion.
- (6) All applicants wishing to claim a Voucher under this Promotion ("**Applicant**") must be current TNT account holders.
