## Overview of previous updates, as of 17 January 2025

Effective February 1, 2025, we will implement the following Demand Surcharge changes for TNT shipments:

- For all shipments from Israel to Europe, US and Canada, LAC, MEISA, Australia and New Zealand, and Rest of the World, the Demand Surcharge will be decreased to US\$0.49 per kilo.
- For all shipments from Europe to Israel, the Demand Surcharge will be decreased to US\$0.49 per kilo.

Effective October 14, 2024, we will implement the following Demand Surcharge changes for TNT shipments:

- For intra-Europe (export and import) Express shipments, the Demand Surcharge will be increase US\$0.82 per chargeable kilo.
- For intra-Europe (export and import) Economy shipments, the Demand Surcharge will be increased to US\$0.60 per chargeable kilo.
- For all shipments from Israel to LAC and to Australia and New Zealand, the Demand Surcharge will be re-instated at US\$1.04 per chargeable kilo.
- For all shipments from Israel to MEISA and Rest of World, the Demand Surcharge will be re-instated at US\$0.93 per chargeable kilo.
- For all shipments from China/Hong Kong SAR China to Israel, the Demand Surcharge will be increased to US\$2.49 per chargeable kilo.
- For all shipments from APAC as well as Australia and New Zealand to Israel, de Demand Surcharge will be increased to US\$1.59 per chargeable kilo.
- For all shipments from MEISA to Israel, the Demand Surcharge will be re-instated at US\$1.48 per chargeable kilo.
- For all shipments from US/Canada, LAC and Rest of World to Israel, the Demand Surcharge will be re-instated at US\$0.49 per chargeable kilo.

Effective September 16, 2024, we will implement the following Demand Surcharge changes for TNT shipments:

- For all shipments from China/Hong Kong SAR China to Europe, the Demand Surcharge will be increased from US\$0.88 to US\$2.00 per chargeable kilo.
- For all shipments from APAC/Mexico to Europe, the Demand Surcharge will be re-instated at US\$1.10 per chargeable kilo.
- For all shipments from Europe to US/Canada, the Demand Surcharge will be re-instated at US\$0.55 per chargeable kilo.
- For intra-Europe (export and import) Priority shipments, the Demand Surcharge will be re-instated at US\$0.33 per chargeable kilo.
- For intra-Europe (export and import) Economy shipments, the Demand Surcharge will be re-instated at US\$0.11 per chargeable kilo.

For all shipments from China to Europe, a surcharge of US\$0.88 per chargeable kilo begins August 12, 2024.

For international (export and import) shipments, the Demand Surcharge will be suspended as of April 29, 2024.

For intra-Europe (export and import) shipments, the Demand Surcharge will be suspended as of January 1, 2024.
