How are these products classified?

Most goods related to perfumes and cosmetics are listed in the 33 and 34 goods groups of the EAEU Commodity Nomenclature of Foreign Economic Activity (EAEU CN FEA).

More details are provided in the Attachment.

What is important for customs clearance?

INFORMATION ON GOODS FOR DECLARATION PURPOSES

Product description is a key source of information for the correct classification of imported goods. Make sure your description of perfume and cosmetic product contains complete information on:

- The composition of the imported cosmetics
- Their intended purpose
- Directions for use
- Type of individual product packaging (consumer packaging), its volume
- Trademark (logo, brand)
- Presence/absence of ethanol in the product



An example of a correct product description:

- Instructions for use or information on the product packaging

Availability of a permit:



The circulation of perfumes and cosmetics in consumer packaging in the Eurasian Customs Union (EACU) is regulated by the 009/2011 "Safety of Cosmetic Products" EACU Technical Regulation.

THE RELEASE OF MENTIONED PRODUCTS INTO CIRCULATION IS ONLY POSSIBLE AFTER OBTAINING A CONFIRMATION OF CONFORMITY IN THE FORM OF:

Where do I apply for it?	Declaration of conformity is provided by an accredited certification body. Please submit documents confirming importation and testing of the samples. In the Russian Federation, Rospotrebnadzor is the registration authority.

Obtaining a license for alcohol-containing products

Some perfume and cosmetic products may contain ethyl alcohol. The state thoroughly monitors the circulation of such products and sets specific limits on their use.



Other restrictions

- Some goods are subject to conformity assessment in the form of declaration of conformity according to Decree No. 982 of the Government of the Russian Federation dd. December 1, 2009; in this case technical regulations of perfumes and cosmetics are not applied for conformity assessment. Such products include contact lens care products or dental and oral hygiene preparations, as well as aerosol household chemicals.
- Some goods may also fall under the requirements of the TR CU 019/2011 "On safety of personal protective equipment" regulations. For instance, such goods include anti-UV products.
- There exist a number of requirements for goods falling within the scope of the TR CU "Safety requirements of food additives, flavorings and processing aids" regulations. These are goods of the 3302 group, for example.
- In some specific cases, a permit or veterinary certificate is required prior to importation of goods. This is true for goods of the 3302 group, for example.



Requirements to the marking of goods

The marking of goods is subject to the following requirements, depending on the purpose of importation.

PURPOSE OF IMPORTATION:

Samples for product certification

Marking by the manufacturer of the goods is sufficient

Batch of products for circulation in the market

Mandatory labelling with a single EAU circulation marking for each product unit is required. Such marking shall be affixed prior to importation into the Russian Federation.
