Acceptable and Prohibited DG Substances



Scope: the TNT Fixed Networks (Road & Air) including PUD and feeders.

The table below specifies which Dangerous Goods (DG) can be accepted for transport on the TNT networks. The provisions apply to air, road and sea transport, to primary and subsidiary hazard, to empty packaging as well as to Excepted Quantities.

(*4) "Wet Batteries" can be accepted for transport from, through and to ADR affiliated counties by ROAD only, providing that:

- they are exempted from the regulations by fully complying with the requirements of ADR Special Provision 598;

- there are no ferry crossings in the shipment's routing
