Additional Handling

Shipments that exceed our standard dimensions, or otherwise cannot be handled by our automated conveyor belts, will incur one of the following surcharges*:

Non-conveyable

This applies if an item weighs less than 30 kg, and exceeds any of the following dimensions:
- 121cm in length, 76cm in width, 76cm in height
- but does not exceed 274cm in length or 420cm in length and girth combined.
The length and girth is length plus (two times the height) plus (two times the width).

Exceeding dimensions

This applies if an item weighs 30 kg or more, and exceeds any of the following dimensions:
Express: 1.2 m (L) x 1.2 m (W) x 1.5 m (H),
but does not exceed 302cm in length.

Economy Express: 2.4 m (L) x 1.2 m (W) x 1.8 m (H)
but does not exceed 302cm in length.

AHS Packaging

This applies if an item:
- is not fully encased in an outer shipping container or packaging;
- is encased in an outer shipping container or packaging not made of corrugated fiberboard (cardboard) materials, including but not limited to metal, wood, canvas, leather, hard plastic, soft plastic, or expanded polystyrene foam (e.g., Styrofoam);
- is encased in an outer shipping container or packaging covered in shrink wrap or stretch wrap;

- is round or cylindrical, including (without limitation) mailing tubes, cans, buckets, barrels, tires, drums or pails;
- is bound with metal, plastic or cloth banding, or has wheels (e.g. a bicycle), casters, handles, or straps, including packages where the outer surface area is loosely wrapped, or where the contents protrude outside the surface area;
- could become entangled in or cause damage to other packages or our sortation system

Additional Handling Unauthorized Charge (Dimensions) This applies if an item is extremely long or bulky and will require additional sorting by hand or by special machines. This surcharge applies if a shipment contains: Any item (less than 30kg) that exceeds - 274cm in length or - 420cm in length and girth combined*. This does not apply to an item, package, or box on a standard pallet (EUR, EUR1, EUR2, EUR6). Any palletised item (<u>more than 30kg</u>), that exceeds - 302cm in length The length and girth is length plus (two times the height) plus (two times the width). IMPORTANT: We will not accept items that meet above criteria, and we may refuse or return eligible items to the shipper. If found in our system, these items will be subject to the Unauthorized Charge (Dimensions) . However, in exceptional cases and at our sole discretion, items may still be accepted and delivered, in which case the Unauthorized Charge (Dimensions) will apply. Non-stackable shipment This surcharge applies to any shipment containing at least one piece, skid or pallet that is non-stackable. Non-stackable means that a piece, skid or pallet cannot be stacked vertically in a safe and secure manner. This surcharge applies once per shipment, even if multiple pieces identified as non-stackable are bundled in a shipment. A shipment can attract both one Additional Handling surcharge and the Non-stackable surcharge. (Note: The billed surcharge does not represent a bookable service and does not contain any guarantee to the extent that the respective shipments may not possibly be stacked at one point during transport.) CUSTOMS SERVICES

Multiple-line Entry

A service charge applied for multi-line item entries for shipments with multiple commodity types for clearance.

Transit document / In-bond Entry

Allows a shipment to be transported under transit customs procedure (e.g. T1 document in Europe).

Customs Storage

Storage charges apply when the shipment cannot be released from TNT/other facility due to customs requirements, insufficient clearance information or upon customer request.

U.S. Inbound Processing Fee

Applies to U.S. import shipments in connection with the processing and clearance of those shipments for clearance.

Disbursement Fees

Payment of Duty and Tax (D&T) charges to customs authorities on behalf of the customer.

Other Government Agencies

Additional handling charges associated with OGA clearance, e.g. Food & Drug Administration (FDA), health ministries, departments of agricultures, CITES.

Entry Amendment

Amending initial clearance entry information per customer request or identified error by customer.

Temporary Import

Per customer request special customs entry for temporary import clearance.

UK-EU Customs Surcharge
