



Terms and Conditions Ship Europe! Promotion

1. Information on how to enter Ship Europe! Promotion (**'Promotion'**) and the Prizes form part of these Terms and Conditions. Entry into this Promotion constitutes acceptance of these Terms and Conditions.
2. The promoter is TNT Australia Pty Ltd (ACN 000 495 269) of 201 Coward Street, Mascot, NSW 2020 Australia (**'TNT'**).
3. For the purpose of these Terms and Conditions, the following definitions will apply:

'Europe' means the following countries:

Albania, Andorra, Armenia, Austria, Azerbaijan, Belarus, Belgium, Bosnia & Herzegovina, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Faroe Islands, Finland, France, Georgia, Germany, Gibraltar, Greece, Greenland, Holy See (Vatican City State), Hungary, Iceland, Ireland, Italy, Kosovo, Latvia, Liechtenstein, Lithuania, Luxembourg, Macedonia (FYROM), Malta, Moldova, Monaco, Montenegro, Netherlands, Norway, Poland, Portugal, Romania, Russia, San Marino, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland, Turkey, Ukraine and United Kingdom.

'TNT International Consignment' means a consignment, which is either collected by TNT from an address:

- (i) In Australia and delivered to an address in Europe; or
- (ii) In Europe and delivered to an address in Australia

and has a minimum weight of 1kg per consignment note.

'TNT International Service' means any of the following TNT offered services:

International 9:00 Express, International 12:00 Express, International Express, International Economy Express and International Direct Express only.

4. Entry to this Promotion is open to the party (**'Eligible Entrant'**) which:
 - 4.1 Is an Australian registered company;
 - 4.2 Has an existing account with TNT prior to the commencement of the Promotional Period; and
 - 4.3 Receives an electronic direct mail (email) communication from TNT inviting entry to this promotion.

Individuals directly involved in the conduct of this Promotion who are employees of TNT, or agencies associated with this Promotion, and their immediate families, are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin. 5. The Promotion commences at 9.00am (AEDT) on Monday 25 February 2019 and closes at 5.00pm (AEST) Friday 31 May 2019 (**'Promotional Period'**). Eligible Consignments must be booked and shipped during the Promotional Period.



6. To enter into this Promotion:
 - 6.1 Eligible Entrants must book a TNT International Consignment to or from Europe and must be shipped using any of the TNT International Services ('**Eligible Consignment**');
 - 6.2 Eligible Entrants must use the Account Number specified on the electronic direct mail (email) when booking; and
 - 6.3 TNT must have collected from the Eligible Entrant the Eligible Consignment within the Promotional Period.
7. Each Eligible Consignment booked by the Eligible Entrant and collected by TNT during the Promotional Period earns the Eligible Entrant an automatic entry into the promotion.
8. The Draw will take place at 2.00pm (AEST) on Friday 14 June 2019 at 201 Coward Street, Mascot, NSW 2020. The winners will be notified in writing and/or by a phone call. The winners may also be published on TNT's website tnt.com.au one (1) week after the draw date – Friday 21 June 2019.

The first four (4) eligible entries drawn, which have been submitted by Eligible Entrants in accordance with these Terms and Conditions, will win an Ultimate Ears Boom 3 Portable Bluetooth Speaker ('**Prize**') each. There will be four (4) Prize winners to be drawn. Therefore four (4) Prizes in total. The Prize RRP value is AU\$199.95 each, with a total RRP value of AU\$799.80.
