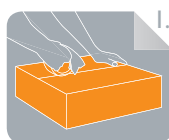

TNT Enhanced Liability. We've got you covered.



At TNT, our business is to ensure that your shipment, whether a pallet, parcel or document, arrives on time and in perfect condition. We take this responsibility seriously, but it is still prudent for you to protect your valuable goods against potential loss or damage in transit. That's why TNT Enhanced Liability gives you added peace of mind.

TNT offers enhanced carrier liability on all express and economy express consignments up to a maximum value of €25,000 or the declared invoice value of your goods, whichever is lower. For this Enhanced Liability cover, a fee of 1% of declared invoice value of goods or HKD38 per consignment, whichever is greater, will apply.

It is important to note that we are not able (and will not charge) to provide Enhanced Liability cover at this time to the following countries:

- Afghanistan
- Democratic Republic of Congo
- Iran
- Iraq
- Ivory Coast
- Liberia
- Nigeria
- North Korea
- Pakistan
- Somalia

Exclusions

The cover is subject to the exclusions as specified in our general terms and conditions (Clause 14 and Clause 17 in particular), available at www.tnt.com.hk

Examples of these exclusions include (but not limited to):

- Loss/damage attributable to the willful misconduct of you or your agents
- Ordinary leakage, loss in weight or volume, or ordinary wear and tear
- Loss/damage caused by insufficiency or unsuitability of packing or preparation of the subject matter
- Loss/damage caused by delay
- Loss/damage arising from the use of any weapon employing atomic or nuclear fission and/or fusion or other like reaction or radioactive force or matter
- War risks on land

High risk goods that are always subject to prior approval

The cover is subject to the exclusions as specified in our general terms and conditions, available at www.tnt.com.hk

Examples of high risk goods include (but not limited to):

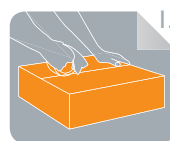
- Hazardous goods
- Livestock, bloodstock and living creatures
- Antiques and objects of art
- Breakables such as glass, bottles etc
- Tobacco, cigarettes and spirits
- Fire arms and other weapons and ammunition
- Charity goods or humanitarian aid
- Perishable goods carried in a cargo space controlled by mechanical equipment
- Bulk goods
- Precious metals, stones or jewellery, watches
- Documents, money or valuable paper
- Architectural models and prototypes
- Goods subject to customs excise
- Motor vehicles
- Fur and fur garments

Note that where a consignment has a value in excess of €25,000, TNT will cover (and make the necessary charge) the first €25,000 value of goods only. If you would like to arrange cover for a consignment where the value is in excess of €25,000, please contact TNT Customer Service Hotline at 2331 2663 to gain your quotation and approval before shipping.

Kindly note that the effectiveness of Enhanced Liability cover is conditional upon your payment of the indicated charge.
