I undertake to present the consignments covered by this order at the customs office indicated in this order within the prescribed time limit, intact and in compliance with the measures taken by the customs authorities to ensure the identification of the goods, as required by Article 233(3) of the Regulation No. 952/2013 of the European Parliament and of the Council of October 9, 2013 establishing Union Customs Code, and I assume responsibility under the Fiscal Penal Code in the event of a transit violation. The ordering party undertakes to compensate FedEx for any damage it incurs, including covering in full any third-party claims, public-law charges (including customs duties, taxes, fines and fees), costs of proceedings, legal costs, and any other losses or expenses (including indirect ones) arising from the ordering party's breach of these obligations. The ordering party's liability also extends to cases where the breach resulted from the fault of its consignees, contractors, or other entities acting on its behalf or for its benefit. Compensation shall be paid at FedEx's first request, no later than 7 days after receipt of the demand, without FedEx first having to pursue claims against other entities. These provisions do not exclude or limit any rights of FedEx arising from the law or from other contractual provisions.
