Overview of previous updates, as of 5 September 2025

(We reserve the right to implement or suspend Demand Surcharges at any time, without prior notice.)

From September 22 to October 19, 2025*, we will implement the following Demand Surcharge changes for TNT shipments:

- For intra-Europe (export and import), and Israel to Europe *Economy* shipments, the Demand Surcharge will be re-instated at €0.10 per kilo.
- For intra-Europe (export and import), and Israel to Europe *Express* shipments, the Demand Surcharge will be re-instated at €0.30 per kilo.
- For all shipments from Europe to US/Canada, LAC, MEISA, Australia, New Zealand, and Rest of the World, the Demand Surcharge will be re-instated at €0.40 per kilo.
- For all shipments from LAC to Europe, the Demand Surcharge will be re-instated at €0.20 per kilo.
- For all shipments from APAC, China and Hong Kong SAR China, Australia and New Zealand, to Europe, the Demand Surcharge will be re-instated at €1.00 per kilo.

Effective July 21, 2025, we will implement the following Demand Surcharge changes for TNT shipments:

- For all shipments from Europe to Israel, the Demand Surcharge will decrease from €1.50 to €0.45 per kilo.
- For all shipments from Israel to Europe, the Demand Surcharge will be suspended.

Effective June 22, 2025*, we will implement the following Demand Surcharge changes for TNT shipments:

- For all shipments from Europe to Israel, the Demand Surcharge will increase from €0.45 to €1.50 per kilo.
- For all shipments from Israel to Europe, the Demand Surcharge will be reinstated at €1.50 per kilo.

* Bulgaria's effective date: June 25, 2025

Effective June 1, 2025, we will implement the following Demand Surcharge changes for TNT shipments:

- For all shipments from MEISA, APAC, China, Hong Kong SAR China, Australia, and New Zealand to Europe, the Demand Surcharge will be suspended.

Effective May 5, 2025, for all shipments from Israel to Europe, the Demand Surcharge will be suspended.



Effective February 1, 2025, we will implement the following Demand Surcharge changes for TNT shipments:

- For intra-Europe shipments, the Demand Surcharge will be suspended. This suspension does not apply to shipments to and from Israel.
- For all shipments from Europe to US and Canada, LAC, MEISA, Australia and New Zealand, and Rest of the World, the Demand Surcharge will be suspended.

Effective October 14, 2024, we will implement the following Demand Surcharge changes for TNT shipments:

- For all shipments from Europe to Israel and Israel to Europe, a Demand Surcharge will be applied at €0.45 per kilo.
- For all shipments from Europe to LAC and to Australia and New Zealand, the Demand Surcharge will be re-instated at €0.50 per kilo.
- For all shipments from Europe to MEISA and Rest of World, the Demand Surcharge will be re-instated at €0.40 per kilo.
- For all shipments from MEISA to Europe, the Demand Surcharge will be re-instated at €0.90 per kilo.

Effective September 16, 2024, we will implement the following Demand Surcharge changes for TNT shipments:

- For all shipments from China/Hong Kong SAR China to Europe, the Demand Surcharge will be increased from €0.80 to €1.82 per kilo.
- For all shipments from APAC* to Europe, the Demand Surcharge will be re-instated at €1.00 per kilo.
- For all shipments from Europe to US/Canada, the Demand Surcharge will be re-instated at €0.50 per kilo.
- For intra-Europe (export and import) Express shipments, the Demand Surcharge will be re-instated at €0.30 per kilo.
- For intra-Europe (export and import) Economy shipments, the Demand Surcharge will be re-instated at €0.10 per kilo.

For all shipments from China to Europe, a surcharge of €0.80 per kilo begins August 12, 2024.
