Additional Handling

Express: 1.2 m (L) x 1.2 m (W) x 1.5 m (H), Economy Express: 2.4 m (L) x 1.2 m (W) x 1.8 m (H)

Special Handling

Dry Ice

Biological Substance Category B

Service charge for shipments containing genetically modified organism (UN3245).
